### Proposed Action Description:

This NEPA document reviews the demolition and removal of the original Zone 10 Concrete Batch Plant. A prior review for this action, titled "Vulcan Materials Concrete Batch Plant Removal, D&D-23-001-C," was completed in April 2023 identifying outstanding compliance issues. The purpose of this current document is to assign outstanding compliance issues to Gilgal Stones Consulting, LLC, the new owner of the original Concrete Batch Plant.

Scope of work includes removal of:

- Two hoppers with conveyors;
- Two buildings; one with a concrete slab and one without;
- One aggregate bin slab (if necessary);
- Three silos;
- Two chemical sheds;
- One aboveground storage tank (AST); and
- Rock and sand piles (if necessary).
