

**DOE/NNSA DETERMINATION AND SUPPLEMENT ANALYSIS FOR THE FINAL  
ENVIRONMENTAL IMPACT STATEMENT FOR THE CONTINUED OPERATION OF THE  
PANTEX PLANT AND ASSOCIATED STORAGE OF NUCLEAR WEAPON COMPONENTS**

The National Nuclear Security Administration (NNSA) Production Office (NPO) of the Department of Energy (DOE)/NNSA has issued a *Determination and Supplement Analysis for the Final Environmental Impact Statement for the Continued Operation of the Pantex Plant and Associated Storage of Nuclear Weapon Components*.

The Final Environmental Impact Statement, also known as the Sitewide Environmental Impact Statement (SWEIS) evaluated the potential impacts of continued operation of the Pantex Plant between 1996 and 2006. DOE's *National Environmental Policy Act* (NEPA) implementing regulations at Title 10 Code of Federal Regulations (CFR) 1021.330(d) requires evaluation of a SWEIS at least every five years through preparation of a Supplement Analysis (SA) as provided in 10 CFR 1021.314. A SA was prepared and approved in 2013. This SA compares current conditions to those predicted by the SWEIS during this period and evaluates potential impacts between 2018 and 2023 to determine whether the impacts identified in the SWEIS remain valid.
